V. - NATURE AND AMOUNT OF BENEFITS

Section I : Accidental Bodily Injury

Committed to pay to the Insured person or his/her beneficiary(ies) the following benefits in case of insured Accident:

- Death : **25.000 EUR**
- Total Permanent Disability :..... **25.000 EUR**
Reducible in case of partial disablement according to the scale of Chubb
- Temporary Total Disability*..... **20 EUR**
Maximum 180 days – Deductible 7 days
- Psychological counselling: **750 EUR**
- Lifestyle prejudice : **10.000 EUR**
- Search, aid and rescue expenses: **20.000 EUR**

Only the benefits detailed above are covered under the policy in accordance with the Section I « **Accidental Bodily Injury** » of the General terms.

(*) We mean by « Temporary Total Disability » :

In the case of an Accident making the Insured Person totally unable to carry out his job or routine paid activities for a certain time, and when a competent Medical Authority has granted him sick leave, We shall pay him an indemnity for each day covered by the sick leave, of **20 EUR**.

However, the indemnities that We shall pay to the Insured Person shall be in addition to any payments made by the Social Security and/or any other welfare scheme or private health insurance, this being up to the limit of the actual daily salary of the Insured Person.

This indemnity is due for a maximum period in accordance with the same Accident indicated in the Chapter « Nature and Amount of Cover » of the Special Conditions and, unless agreed to the contrary, shall be paid only after the Excess period indicated above.

Return to work, even if partial, of the Insured Person shall stop payment of the indemnity.

Any temporary total disability originating from the same event is considered as a relapse when the period between two temporary total disabilities is less than **sixty (60)** days.

(*) « Search, aid and rescue expenses » :

In the case of an Accident having led to search, aid and rescue expenses, (sea, mountain, forests or deserts), We will reimburse, on presentation of supporting invoices, the expenses borne by the Insured Person of public or private organisations who may have intervened, within the limit of the maximum of **20.000 EUR**.
